ORDINANCE NO. 19-2016

AN ORDINANCE APPROVING AN AMENDMENT TO THE ZONING ORDINANCE  
ON RECOMMENDATION BY THE CLARK COUNTY PLAN COMMISSION

WHEREAS, this Board of Commissioners of Clark County, Indiana (this "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, this Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code 36-1-2-9; and,

WHEREAS, the Clark County Plan Commission has advisory authority regarding zoning pursuant to Ind. Code 36-7-4, *et al*; and,

WHEREAS, the Clark County Plan Commission has passed Amendment 13 to Ordinance 17-2007, which states as follows:

**Article V: Definitions- Page 10 – The definition of "Portable Sign" is added and reads:**

**Portable Sign – Any sign or advertising device not permanently attached to the ground nor designed to be permanently attached to the ground or permanent structure or is only affixed by means of tie-downs, straps, or stakes; a sign designed to be transported by means of wheels; A or T-framed signs; and signs attached to or painted on vehicles or storage pods or semi-freights parked and visible from the public right-of-way, unless said vehicle is used, driven, or moved as part of the day-to-day operations of the business.**

**Article XIX: Temporary Sign Permits – Page 51 – No. 5 listed under "Temporary Sign Permits" is deleted and the following language is added:**

**5. Portable, folding, or moving signs. Issuance of the permit shall be for a maximum of thirty (30) consecutive days within one (1) year. A portable sign may not be placed closer than ten (10) feet to a street or highway right-of-way or where it blocks traffic vision.**

**NOW, THEREFORE, BE IT ORDAINED** by this Board of Clark County Commissioners as follows:

1. That the Clark County Plan Commission Amendment 13 to Ordinance 17-2007, is Approved and the following Amendment shall be incorporated within the Clark County Zoning Ordinance, Ordinance No. 17-2007 as Amendment 13:

**Article V: Definitions- Page 10 – The definition of “Portable Sign” is added and reads:**

**Portable Sign – Any sign or advertising device not permanently attached to the ground nor designed to be permanently attached to the ground or permanent structure or is only affixed by means of tie-downs, straps, or stakes; a sign designed to be transported by means of wheels; A or T-framed signs; and signs attached to or painted on vehicles or storage pods or semi-freights parked and visible from the public right-of-way, unless said vehicle is used, driven, or moved as part of the day-to-day operations of the business.**

**Article XIX: Temporary Sign Permits – Page 51 – No. 5 listed under “Temporary Sign Permits” is deleted and the following language is added:**

**5. Portable, folding, or moving signs. Issuance of the permit shall be for a maximum of thirty (30) consecutive days within one (1) year. A portable sign may not be placed closer than ten (10) feet to a street or highway right-of-way or where it blocks traffic vision.**

2. This Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.




