RESOLUTION NO. 18 -2012

**A RESOLUTION RECOMMENDING THE  
CHANGE OF NAME FOR A PORTION OF  
ST. JOHN ROAD TO CARL POPP RIDGE ROAD**

WHEREAS, this Board of Commissioners of Clark County, Indiana (this "Board"), is the executive body of Clark County government pursuant to the provisions of IND. CODE § 36-2-2-3; and,

WHEREAS, this Board caused a public improvement project utilizing federal funding provided through the Indiana Department of Transportation to be completed for a portion of St. John Road from the point that it crosses the Clark County line to its intersection with Starlight Road as shown on the map attached hereto as Exhibit "A" (the "Project");

WHEREAS, the completion of the Project significantly enhances public safety by the removal and/or realignment of several steep curves and creating a new route that allows access to the Starlight and Knobs areas with much less risk; and,

WHEREAS, this Board is further aware that for many years Carl Popp, a distinguished citizen of Clark County who passed away in 2009, was a tireless advocate for construction of the improvements that have now been implemented by the Project; and,

WHEREAS, this Board believes it would be a fitting tribute to re-name the newly improved paved roadway within the Project area to "Carl Popp Ridge Road"; and,

WHEREAS, this Board acknowledges that the ultimate authority for any such change of name is subject to the jurisdiction of the Clark County Plan Commission, and this Board now

adopts this Resolution for the purpose of communicating its support of such change of name to the Clark County Plan Commission.

**NOW, THEREFORE, BE IT RESOLVED** by this Board of Clark County Commissioners as follows:

1. Recommendation for Change of Road Name. Based on the foregoing, it is the recommendation of this Board that the Clark County Plan Commission should favorably consider and approve changing the name of the existing paved roadway within the Project area as shown on the map attached hereto as Exhibit "A" from "St. John Road" to "Carl Popp Ridge Road".

2. Effective Date of Resolution. This Resolution shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.



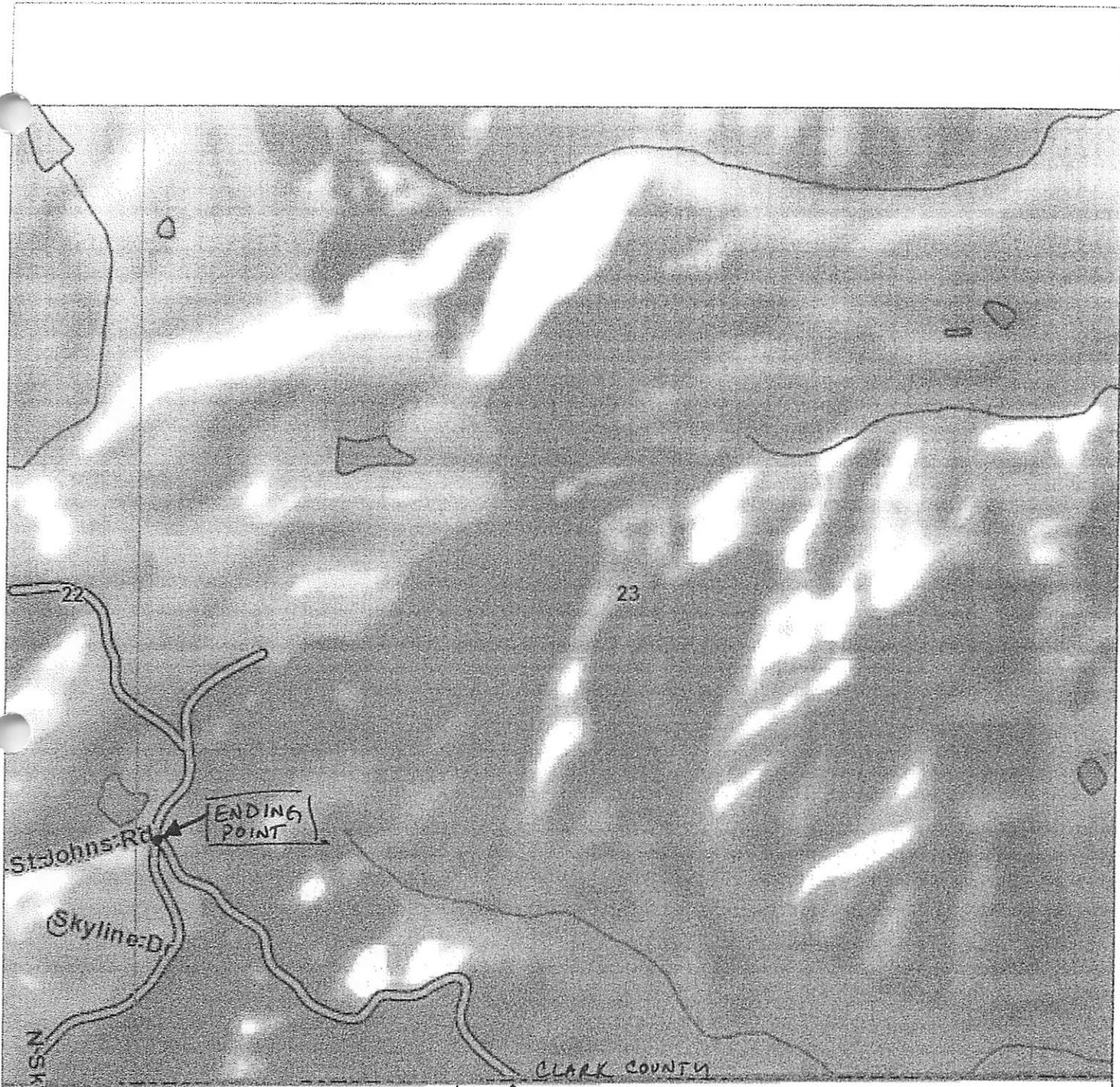
