WHEREAS, on the 11th day of May, 2022, the Clark County Plan Commission passed Resolution 6-2022 (see the said Resolution 6-2022 attached hereto as Exhibit "A") with an unfavorable recommendation to reclassify certain property on the County's zoning maps as identified in the said Resolution.

NOW, THEREFORE, BE IT ORDAINED by the Board of Clark County Commissioners as follows:

1. That the zoning request as set forth in Plan Commission Docket 2022-04-PC, as attached hereto, is hereby approved, and the County's zoning maps are reclassified pursuant to the attached Resolution.

Clark County Plan Commission Staff Report: May 11, 2022

Docket 2022-04-PC:

Renaissance Design Build., Inc. requests a zone map amendment from R2 to R4 for a Multi-Family Residential at 4218 Perry Crossing Rd., Sellersburg, In. 47172 (10-10-16-700-180.000-032).

APPLICATION INFORMATION:

- The applicant has provided all materials for a complete application with the exception of:
 - o Proof of Water & Sewer service
 - Revised preliminary site plan: The petition is for Re-zoning, however, the site plan would not conform with the UDO. Re-zoning does not approve the site plan. These issues can be addressed in Development plan approval.
- The application was sent to Checkpoint Agencies for review on 03/14/2022.
 - Todd Webb at the Health Dept. stated the applicant must go through the State for approval of lateral septic field.

STAFF COMMENTS AND RECOMMENDATION:

- Staff recommends consideration on the following:
 - o The Clark County Comprehensive Plan identifies this parcel within a growth area.
 - The current character and conditions in this area is medium density residential, storage units and interstate.
 - o The rezoning supports responsible development and growth in the county.
 - o Sellersburg Water/Sewer states they are at capacity and cannot provide service
 - o Applicant must apply for a Variance if they are approved for septic based on UDO

The area is not served by municipal sewer service and R4 requires municipal sewer. Staff only recommends approval if sewer service is provided.
