ORDINANCE VACATING PUBLIC WAY

WHEREAS, IC 36-7-3-13 empowers the legislative body of a county to vacate a public way;

WHEREAS, the Board of Commissioners of Clark County, Indiana (the "Board") is the county executive pursuant to IC 36-2-2 and is also the county legislative body pursuant to IC 36-1-2-9;

WHEREAS, a public hearing was properly advertised and conducted on the 23rd day of February 2006, regarding the propriety of vacating an alley in New Washington, Clark County, Indiana;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners that the following public way be vacated as a public way, to wit:

Beginning at the North corner of Lot 55 of the Johnson addition to the Town of New Washington as shown in Plat Book 3 Page 44 drawn from the original Surveys. THE TRUE PLACE OF BEGINNING,
Thence S 90°00'00" E a distance of 180.00 feet along the South line of a 10' wide alley to a 5/8" rebar at the North East corner of Lot 56,
Thence N 00°00'00"E a distance of 10.00 feet to the South East corner of Lot 41
Thence N 90°00'00" W a distance of 180.00 feet to a nail, at the South West corner of Lot 42
Thence S 00°00'00" W a distance of 10.00 feet to THE TRUE PLACE OF BEGINNING,

Containing 0.041 Acres

Effective Date: This Ordinance shall be in full force and effect after due publication as required in IC 5-3-1-2(h) which was given ten days prior to its consideration for adoption and passage and will be published one (1) time within thirty (30) days after the passage of the ordinance. The first publication was made February 8, 2006, in the Evening News, a daily newspaper of general circulation published in the City of Jeffersonville, County of Clark, Indiana, and the further publication will be by the same newspaper within the thirty (30) days of adoption and passage.



Thence N 00°00'00"E a distance of 10.00 feet to the South East corner of Lot 41
Thence N 90°00'00" W a distance of 180.00 feet to a nail, at the South West corner of Lot 42
Thence S 00°00'00" W a distance of 10.00 feet to THE TRUE PLACE OF BEGINNING,

Containing 0.041 Acres




